The jurors, who met last Saturday week for the first time, were told there are 14 commercial leases along the river foreshore administered by the state, ranging from \$1100 to

The lease timeframes of 20 years were recently extended to 30 years with "some leases approved for operations not related to boating". The jury may, if it sees merit in the suggestion, consider what commercial uses should be allowed in the river. And they may ponder whether such ventures as "new floating shops

permanently attached to a jetty", commercial use of amphibious vessels, new commercial jet ski businesses and Jettev or Flyboard equipment are appropriate for Nosa. The 26-member second community jury took a ferry trip to see some of the issues first-hand with council's rivers and coast environment officer Jan Maddin, highlighting the

proliferation of abandoned and derelict vessels, river clutter and the effect on visual amenity. Noosa Council

environment and planning manager Kerri Coyle said current management

content managements arrangements were complex, while the level of resources and a state-wide management approach were also having an impact. The jury members have

compiled a list of issues they'd like to hear more about and the experts they wish to consult. Council and newDemocracy Foundation are now working on delivering research and speakers for the jury when it next meets on September 16.
