
The key findings

- 1 The current system of government is broken ...
- 2 ... due to the self-interest of politicians, and complexity of issues
- 3 But there is a strong case for improving the system, with positive reactions to citizen juries

But first, some context


10 years ago Australians could agree on the big issues, but today people are concerned about many issues

Issues of concern (%)



Hypothesis: difficult for our current democracy to cope with this complex system of issues; hence fear mongering/wedge politics

Who are the most trusted people in Australian society?



<u>Journalist</u> 36%



<u>Politician</u> 69%



Australians place little trust in the government and the mainstream media

Now, onto the specifics...

Q1. How much do you agree or disagree that:

- Everyday people should be allowed to make decisions on civic/governmental issues that impact their lives, i.e. health, education, transport, energy, wages, tax and welfare
- The current Australian political system is a broken system and isn't working
- The current Australian political system, where we elect representatives to form a governing body, is the best system there is
- The current Australian political system delivers positive and fair outcomes for the majority of Australians
- Everyday people should play a bigger part (than they currently do) in governmental decisions that impact their lives, i.e. health, education, transport, energy, wages, tax and welfare.

Q2. You indicated you think the current Australian political system is broken and isn't working. What specifically about the system is broken / what isn't working? Please focus on the system, not specific politicians, people or parties.

Q3. Please read the following and tell us what you think:

[DESCRIPTION OF CITIZEN JURIES SHOWN] How much would you support this system?

Q4. And what makes you say that?

Q5. Which organisations, companies or individuals would you most trust to present your interests on issues, e.g. health, education, transport, energy, wages, tax, community and welfare?

The problem stems from self-interested politicians and the complexity of issues

Reasons why the current system is broken

(coded open-ended responses %)

NET Comments about politicians / parties	<u>~47%</u>
They don't care about the people	~18%
All they do is argue with each other	~11%
They're just in it for the money	~10%
They don't follow through with promises	~7%
NET Comments about not focusing on the right issues	<u>~33%</u>
Not addressing the real issues / nothing gets done	~12%
Not enough focus on welfare / low socio-economic groups	~6%
Wasting money / funds	~5%
Not enough focus on environment / sustainability	~4%
NET The system	<u>~15%</u>
Dislike election/preferential voting system	~7%
Dislike everything about the system	~6%
NET Corruption	<u>~10%</u>




How the concept of citizen juries was presented

"<u>Citizen juries</u>" have been proposed as an alternative or complementary system to the current political system in some countries.

Citizen juries are ordinary people who are given the opportunity to make recommendations to the Government on issues (like health, education, transport, energy, wages, tax and welfare), on behalf of the rest of the population.

Citizen juries involve a random selection of everyday people (like in a jury in court) who are briefed in detail, given all the information they want and need, and given enough time to discuss and deliberate in order to come up with recommendations.

Reasons for and against

For supporters

A move away from politicians who are out of touch

Towards giving 'real', independent people a voice

"It gives the **power back to the people** who are more **in touch** with the day to day needs of average Australians"

On the fence or non-supporters


Need a little more information / evidence that it works

Reassurance that jurors will be well-equipped to make important decisions

"Random people **do not have the experience and knowledge** to make those sort of decisions. They would only do what is good for them and not the country."




Among the 54% who believe the current system is broken

... due to self-interested politicians and the increasing complexity of issues

agree that everyday people should play a bigger role in government decisions This also includes people who think the current system is the best we have

support the idea of a citizen jury: 23% definite support 31% need more convincing Only 12% are against it
